The Global Ethic and Law - Bradley Shingleton 2016-10-20 As a fundamental institution of human societies, law is a deeply influential factor in individual and social activity. Yet its normative status is controversial, particularly in pluralistic, secularized societies. Trade Secrets and Employee Mobility: Volume 44 -

Magdalena Kolasa 2018-02-08
In the increasingly knowledge-and innovation-based economy in which the mobility of the workforce is vital, employees and ex-employees are considered to be one of the biggest threats to the existence of trade secrets. The interests of the former parties to the employment relationship are contradictory: employers want to safeguard their competitive position by limiting use of information, and employees want to use that information to pursue their professional career. Magdalena Kolasa analyses existing guidelines that determine the extent to which former employees may use information learned during service. She proposes criteria for a balanced enforcement of trade secrets, discussing the

statutory and implicit confidentiality duties, contractual protection, and remedies. Drawing from the laws of Germany, UK, and USA, and considering the EU Trade Secrets Directive, this book advocates an approach which recognises the value and functions of trade secrecy both within companies and in the context of public policy.

Vermeer and the Delft School - Walter A. Liedtke 2001

Walter Liedtke, curator of European paintings at the Metropolitan Museum of Art in New York, has assembled a splendid catalog of Vermeer and his artistic milieu. Seven lengthy, well-illustrated chapters (Liedtke wrote five, Dutch art historians Michiel Plomp and Marten Jan Bok wrote the others) describe life in the city of Delft; the painters Carel Fabritius, Leonart Bramer, and others who preceded Vermeer; the careers of Vermeer and De Hooch; the making of drawings and prints in 17th-century Delft; and the collecting of art in the same period. The catalog follows each painting, print, and drawing accompanied by a lengthy catalog essay.

This publication provides an unparalleled comparative analysis of two "hot topics" in the field of antitrust and unfair competition law with regard to a number of key countries. The first part of the book examines the prohibition of abuse of a dominant position and globalization in relation to two broad questions: first, whether there is consistency between the approaches of different jurisdictions to the notion of abuse, and, second, whether there are too many restrictions on legal rights and business opportunities resulting from the prohibition of abuse of dominance. The international report drafted by Professor Pinar Akman reveals that there are as many similarities as differences between the approaches of the twenty-one jurisdictions studied and presented in this book. This is an invitation to read the excellent international report as well as the reports on specific jurisdictions in order to

grasp the variety of arguments and approaches of this antitrust area, which may, on the surface, appear alike. The second part gathers contributions on the question of protection and disclosure of trade secrets and know-how from various jurisdictions. The need for adequate protection of trade secrets has increased due to digitalization and the ease with which large volumes of misappropriated information can be reproduced. The comprehensive international report, prepared by Henrik Bengtsson, brings together these reflections by comparing various national positions. The book also discusses the resolutions passed by the General Assembly of the International League of Competition Law (LIDC) following a debate on each of these topics, and includes proposed solutions and recommendations.

Deutsch, Abstract: Im Folgenden wird das Westermann Lesebuch für das 5. Schuljahr untersucht. Es wurde vom Georg Westermann Verlag in Braunschweig 1968 verlegt. Die Herausgeber des Buches sind Gerhard Frank, Hans Maier, Gunter Otto und Walter Riethmüller. Für den Einbandentwurf und das Layout war Gerd Gücker zuständig. Die Analyse des Westermann Lesebuches 5 erfolgt mithilfe des zugehörigen Buches „5. Schuljahr. Analysen und Interpretationen“, das im gleichen Jahr ebenfalls von Westermann herausgegeben wurde. Letzteres enthält einige Zusatzinformationen zu im Buch gegebenen Texten, erklärt des Weiteren weshalb die Auswahl auf eben diese Texte fiel und gliedert sie nach Themengruppen. Außerdem gibt es einige Anregungen zu möglichen Frage und Aufgabenstellungen für den Lehrer oder die Lehrerin, die zu fast jedem Text individuell erstellt wurden. Das Lehrwerk wird nach gegebenen Kriterien

analysiert. Zur Auswahl der Kriterien wurden die Kriterien der Lehrwerkanalyse von Eckehard Czucka sowie die Analysekriterien für Lesebücher " von Härle und Steinbrenner verwendet. Bei der Analyse wird auf die Struktur des Lehrwerks eingegangen, auf die in den Texten verwendete Sprache, den Umfang beziehungsweise die Länge der Texte, die vertretenen Epochen und AutorInnen und die Themen der Texte. Der letzte Punkt der Hausarbeit ist die abschließende Stellungnahme, in der anhand all der analysierten Punkte eine zusammenfassende Beurteilung und ein abschließendes Urteil über das Buch und seinen Nutzen sowie die Zweckdienlichkeit und Anwendbarkeit im Unterricht gefällt wird.

The long tradition of Western political thought included kinship in models of public order, but the social sciences excised it from theories of the state, public sphere, and democratic order. Kinship has, however, neither completely disappeared from the political cultures of the West nor played the determining social and political role ascribed to it elsewhere. Exploring the issues that arise once the divide between kinship and politics is no longer taken for granted, The Politics of Making Kinship demonstrates how political processes have shaped concepts of kinship over time and, conversely, how political projects have been shaped by specific understandings, idioms and uses of kinship. Taking vantage points from the post-Roman era to early modernity, and from colonial imperialism to the fall of the Berlin Wall and beyond this international set of scholars place kinship centerstage and reintegrate it with political theory.

Originally published in 1987, this thesaurus is concerned with the spoken languages of Africa. Languages are grouped into a relatively large number of sets and subsets within which the relationship of languages to one another is locally apparent and uncontroversial. The volume presents the languages in classified order with notes on each language, their variant names and immediate classification, and reference to the sources consulted. One section offers an exhaustive list of the languages spoken as home languages by local communities in each state, together with details of languages widely used for inter-group communication,

given official recognition, or used in education or the media. There are brief phonological analyses of a broad sample of some 20 African languages and a comprehensive bibliography and language index to the whole work

The various efforts to develop a Marxist philosophy of science in the one time 'socialist' countries were casualties of the Cold War. Even those who were in no way Marxists, and those who were undogmatic in their Marxisms, now confront a new world. All the more harsh is it for those who worked within the framework imposed upon professional philosophy by the official ideology. Here in this book, we are concerned with some 31 colleagues from the late German Democratic Republic, representative in their scholarship of the achievements of a curiously creative while dismaying

repressive period. The literature published in the GDR was blossoming, certainly in the final decade, but it developed within a totalitarian regime where personal careers either advanced or faltered through the private protection or denunciation of mentors. We will never know how many good minds did not enter the field of philosophy in the first place due to their prudent judgments that there was a virtual requirement that the candidate join the Socialist Unity (i.e. Communist) Party. Among those who started careers and were sidetracked, the record is now beginning to be revealed; and for the rest, the price of 'doing philosophy' was mostly silence in the face of harassments the likes of which make academic politics in the West seem child's play.

A Geography of Jihad -

Stephanie Zehnle 2020-01-20
This book addresses the Jihad movement that created the largest African state of the 19th century: the Sokoto Caliphate, existing for 99 years from 1804 until its military defeat by European colonial troops in 1903. The author carves out the entanglements of jihadist ideology and warfare with geographical concepts at Africa's periphery of the Islamic world: geographical knowledge about the boundary between the "Land of Islam" and the "Land of War"; the pre-colonial construction of "the Muslim" and "the unbeliever"; and the transfer of ideas between political elites and mobile actors (traders, pilgrims, slaves, soldiers), whose reports helped shape new definitions of the African frontier of Islam. Research for this book is based on the study of a very wide range of Arabic and West African (Hausa, Fulfulde) manuscripts. Their policies reveal the persistent reciprocity of jihadist warfare and territorial statehood, of Africa and the Middle East.

Stephanie Zehnle is Assistant Professor (JProf) of Extra-European History at Kiel University (Christian-Albrechts-Universität). Her work on African and trans-continental

history includes research on the history of Islam, human-animal relations, and comics in Africa.
